Your Will



Making a Will is one of the most important things you can do to ensure that your wishes are carried out and that your loved ones are provided for in the future.

Your Will tells people who should have your money, property, and possessions

when you die and who will be the 'executor' – the person in charge of following the instructions you leave in your Will and organising your estate.

You can also use your Will to tell people about any other wishes you might have, like instructions for your burial, cremation, or funeral.

Without a Will your money, property and possessions will be shared out according to the law instead of according to your wishes. This could mean that things are passed on to someone you hadn't intended.

Why make a Will?

A Will is vital for parents,

homeowners, and people in long term relationships. Without a Will, you have no control over what will happen to your money, your home, and your belongings when you die. Making a Will is one of the most important things you can do to safeguard your family and ensure that after death, your wishes are carried out. It makes things much easier for your family and friends to sort everything out when you die. Without a Will the process can be more time consuming and stressful. Many people assume their

What is a Will?

A Will is a document that sets out who you want your assets to be passed on to when you die. It is a legally binding document and can be made by anyone over the age of 18.

> estate will pass automatically to their next of kin but without a Will, there is no guarantee this will happen.

Is making a Will difficult and expensive?

Making a Will is easy, quick, and inexpensive. Solicitors will send you a list of things that you need to think about before you meet with them.

Do I need a solicitor?

You don't have to use a solicitor to write a Will, but we strongly advise using one to make sure your Will is viable and to avoid complications later.

How often should I update my Will?

It is a good idea to regularly review your Will regularly so that it continues to reflect changes in your life. Ask your solicitor about making changes to an existing Will or writing a new one.

Who should I include in my Will?

Make a list of all the family and friends you want to remember and consider the types of gifts you want to leave them. For example, you may want to leave a specific amount of money or an item of financial or sentimental value.

Leaving a gift in your will

Q. Are there different ways I can leave a gift to Beaumond House Hospice Care?

Yes. We receive all kinds of gifts in people's Wills and we're grateful for all types of support.

You can leave a specific gift such as personal possessions (a piece of jewellery for example), land, buildings, or specified items such as shares or the contents of a bank account. You can leave a pecuniary gift, which is a cash lump sum. You might like to ask your solicitor to index-link any cash gift to ensure its relative value stays the same over time.

You can leave a residuary gift which is the remainder of your estate after all other gifts and debts have been paid. We understand that caring for your family is a priority. This ensures that your family and loved ones are looked after first and what is left over can then be donated.

Q. What if I want to amend an existing Will?

There is a quick and easy way to add a gift to Beaumond House in your existing Will. If you already have a Will, you can make changes at any time by adding a codicil. A solicitor can advise you on this and make you aware of all the options. Don't make changes to your existing Will without first seeking professional advice, as you could accidentally render it invalid and void.

Q. What information will my solicitor need?

We recommend you contact a professional solicitor or will writer about writing or editing your Will. If you choose to leave us a gift, you will need to state the following information:

Terminology



Beneficiaries

The persons or organisations who will be given a specific gift from your estate, such as money, land, or property.

Executor

The persons who will be responsible for the legal and financial aspects of your estate, appointed by you to make sure the instructions in your Will are carried out.

Pecuniary gift/legacy

A gift of a fixed sum of money. To prevent its 'real value' decreasing over time, the amount can be linked with inflation.

Residuary legacy

A share, or sometimes all, of an estate after all the other payments have been made. One of the advantages of a residuary legacy is that it doesn't lose value over time, and if you leave a proportion to us, you can still ensure other beneficiaries are provided for first.

Specific gift/legacy

A gift of a particular item, such as property, antiques, jewellery, and shares.

We, at Beaumond House know that in the future the need for local hospice care will grow, as will our need for funds. Each gift, regardless of size, makes a difference, and all donations will help our patients and their families to make the most of the time they have together. Please remember that Beaumond House depends on people like you. A gift in your Will costs you nothing today but will help to secure the future of Beaumond House.




